Report on the decisions of the IChO International Jury and Steering Committee in 2020

Temporary modifications in the Regulations of the International Chemistry Olympiad (IChO)

Because of the pandemic a conventional IChO cannot be held in 2020.

For the benefit and motivation of the students preparing for the event, it was proposed that the International Jury of the IChO accepts the following modifications of the IChO Regulations for the duration of the 2020 Olympiad only.

The changes, as all regulation changes required a qualified majority of two thirds of the participating countries. The vote was carried out remotely.

The proposed modifications:

§ 2 Organization and invitation

Observers of newly invited countries can observe the remote olympiad and participate in a videoconference with the Steering Committee to fulfill one year of their observation period

§ 3 Delegations

Each head mentor nominates one or more invigilators responsible for the appropriate running of the remote exam.

The invigilator will:

- Receive the final translated tasks from the organizers DIRECTLY.
 Print the exam.
- Personally supervise the students while they take the exam, as well as video recording the exam proceedings and share the recording with the organisers. The invigilator is responsible for doing this in accordance with any local laws about privacy and data protection.
- Collect the student scripts, scan them and submit the scans to the organizers.
- Accept any other obligations as required by the International Jury.

The invigilator will NOT:

- Receive any advanced information about the content of the exam.
- Interfere with the participants' work during the exam.
- Be involved with the extraordinary Olympiad in any other capacity (e.g. translation, arbitration)

§ 6 International Jury

Meetings of the International Jury can be carried out remotely with the use of appropriate electronic means to discuss the tasks, their marking and the procedures of the IChO.

§ 11 Organization of the IChO Competition

The remotely organized IChO competition consists only of one theoretical exam. This is reflected in the official name of the olympiad.

Jury decision

Country representatives expressed their opinion on three resolutions.

- A) Our country supports the temporary regulation changes.
- B) Our country intends to participate in the competition with the changed regulations.
- C) Our country supports: organizing a remote election to replace Steering Committee members /extending the mandate of present elected SC members with one year.

The results were:

C) 65 extend mandate (No): 12 organize election (Yes)

Steering Committee decision on distributing support

The organizers of the IChO 2020 Remote Theory agreed to receive a reduced participation fee from most countries. The majority of the participating delegations chose to pay the recommended 1000 USD fee. Some delegations (7) were not able to transfer the expected 300 USD minimum.

Support was available thanks to the Chinese Chemical Society in Taipei, IUPAC, the Chemical Society of Japan and the American Chemical Society. The distribution of support is decided by a remote vote of the IChO Steering Committee based on the application of the countries in need.

The SC decided to award support to every applicant country.
